Data protection information regarding audio and video recording data management in the "XXVII Faculty Scientific Students' Association Conference"

The University of Pécs must pay special attention to ensuring the manageability of personal data during data processing and the free movement of such data complying with Regulation 2016/679 of the European Parliament and of the Council (EU) repealing Directive 95/46/EC (hereinafter referred to as the General Data Protection Regulation) as well as to Act CXII of 2011 on the Right to Self-Determination of Information and Freedom of Information (hereinafter: the Information Act), and other legislation, furthermore the National Data Protection and Freedom of Information Authority (hereinafter: NDPFIA).

1. Purpose of information sheet

The purpose of this information sheet is to provide information on the principles of data protection and data management for the production of sound and image recordings in the XXVII Faculty Scientific Students' Association Conference.

3. Scope of personal data

The scope of the managed data covers audio and video recordings made in the XXVII Faculty Scientific Student Conference events.

4. Purpose and legal basis of data management

With the consent of the data subject, the data controller shall manage the audio recordings of the participants at the XXVII Faculty Scientific Students' Association Conference and the audio and video recordings of the lecturers for the production of educational aids in accordance with Article 6 (1) (a) of the General Data Protection Regulation.

5. Duration of data management

Data processing lasts until the consent is withdrawn.

6. The range of persons working with the data, data transmission, data processing

The data can be accessed by authorized civil servants of the University of Pécs.

7. Data security

The controller shall ensure the appropriate security of personal data, including protection against unauthorized or unlawful processing, accidental loss, destruction or damage, by applying appropriate

technical or organizational measures. Further information on the data security measures applied at the University of Pécs can be found in §§ 20-22 of the <u>Data Protection Regulations of the University</u> and in Chapter 4 of the <u>IT Regulations of the University</u>.

8. Right of the data subject

- 8.1. The data subject shall have the right to access the information specified in Article 15 of the General Data Protection Regulation in relation to their data processing, including in particular that the Data Controller shall provide information about
 - what personal data,
 - for what purpose and with what legal basis,
 - from what source,
 - how long to be handled, or
 - whom, when, under what legislation the Data Controller provides access to which personal data
 - or to whom have transferred the data
 - what rights and remedies the Data Subject has during the data processing.
- 8.2. The Data Subject has the right to correct inaccurate (incorrect or incomplete) personal data concerning them on the basis of Article 16 of the General Data Protection Regulation.
- 8.3. The Data Subject has the right to delete personal data according to Article 17 of the General Data Protection Regulation, in particular if the purpose of the processing has ceased or the processing is unlawful or the consent has been withdrawn (and there is no other legal basis for further processing).
- 8.4. The Data Subject has the right to request a restriction on the processing of their personal data as defined in Article 18 of the General Data Protection Regulation. In that case, the personal data subject to the restriction, with the exception of storage, may be processed only with the consent of the Data Subject or for the purpose of making, enforcing or protecting legal claims or protecting the rights of another natural or legal person or in the important public interest of the Union or a Member State.
- 8.5. The Data Subject has the right, as defined in Article 20 of the General Data Protection Regulation, to receive the personal data concerning them provided in a widely used electronic form and to transfer the data to another data controller.
- 8.6. The Data Subject shall have the right to withdraw their consent in writing at any time, without giving reasons, in accordance with Article 7 (3) of the General Data Protection Regulation. The withdrawal shall not affect the lawfulness of the data processing prior to the withdrawal.
- 8.7. The detailed rules for the exercise of the Data Subject's rights related to data management are contained in the Data Protection Regulations of the University of Pécs, which can be viewed at https://pte.hu/adatvedelem.

imminent threat of an infringement of the processing of their personal data. In the event of a breach of their rights, the Data Subject may apply to a court and, at their option, to institute legal proceedings before a court having jurisdiction over their place of residence or stay.
