The abstracts of the submitted student research papers are **evaluated by two opponents appointed by the Vice-Dean for Research**, on the basis of the recommendation by the Scientific Committee and the SSA Presidency. Deadline for evaluation: **16 April 2024**.

The primary task of one of the two opponents is to consider the research methodology/mathematical-statistical standards of the research paper. If either of the two evaluators does not recommend the acceptance of the abstract, the submitted material is to be rejected.

This is to inform you that the abstract uploaded to the registration platform will also be assessed, and the result of the assessment will be included in the performance at the SSA Conference.
